We Samuel Martin Soudy and William Henry Soudy jointly and severally promise to pay to Arthur Russell Esdell or order, as hereinafter mentioned, the sum of Fourteen thousand five hundred pounds for value received, with interest thereon or on so much thereof as shall for the time being remain unpaid at the rate of Seven per cent per annum calculated from this date; the said sum of Fourteen thousand five hundred pounds and interest to be paid in manner following viz

Interest quarterly at the rate aforesaid, such quarter days being the usual quarter days reckoned from this date

Not less than One thousand pounds principal in any one year reckoning January first to December thirty first in manner following viz some amount, being not less than One hundred pounds or some multiplication thereof on any of the said quarter days after a month's notice in writing to be given by us to the said Arthur Russell Esdell of the amount intended to be paid. The whole balance of the principal sum to become immediately due and payable with interest thereon at the rate aforesaid on the occurrence of any one of the following events:

(a) An act of bankruptcy of either of us the undersigned promissors

(b) Whenever the payments made in any year from January first to December thirty first amount to a less sum than One thousand pounds.
